Currently, businesses that generate two cubic yards of solid waste per week, and multifamily properties of 5 units or more, must have organic waste recycling services. Starting January 1, 2022, all businesses and multi-family properties are required to recycle organic waste when SB 1383 regulations go into effect unless you are granted an exemption from your jurisdiction.

It's the Law



California State Assembly Bill 1826 (AB 1826) requires all commercial properties that generate two cubic yards of solid waste per week to recycle their food waste.



California State Senate Bill 1383 (SB 1383)

requires all businesses, multi-family properties and single-family residences to recycle their organic material, including food waste, beginning January 1, 2022.

Currently, businesses that generate two cubic yards of solid waste per week, and multi-family properties of 5 units or more, must have organic waste recycling services.

Starting January 1, 2022, all businesses and multi-family properties are required to recycle organic waste when SB 1383 regulations go into effect unless you are granted an exemption from your jurisdiction.

Food Waste
